What is customs duty on solar panels?

According to TARIC, customs duty for photosensitive semiconductor devices, including photovoltaic cells whether or not assembled in modules or made up into panels; light-emitting diodes, code 8541409000, is 0%. In the HTS tariff system, the duty for solar cells assembled into modules or made up into panels (code 8541.40.60.15) is also 0%.

Germany and all other EU Member States make up a customs territory with uniform customs regulations. Products imported into the EU are subject to EU-wide import regulations, customs tariffs and customs procedures. This means customs duties are only levied once on import into the EU.

Does Germany have a risk-based approach to customs controls?

Germany employs a risk-based approach to customs controls. They focus on high-risk shipments, such as goods from specific countries, sensitive industries, or those with incomplete or inconsistent documentation. Customs duties are taxes levied on imported goods based on their value and classification according to the Harmonised System (HS) code.

All companies based in the EU can be certified as Authorized Economic Operator (AEO) by the relevant main customs Office. As such, they are considered particularly trustworthy in all Member States of ...

You need the EORI number (Economic Operators Registration and Identification number) to identify yourself as an operator who is validly registered for customs clearance in the European Union.
